

Summary of major actions taken by DANB's Board of Directors at the Annual 2020 Board Meeting

DANB Candidate Services Updates

Temporary Candidate Policy Changes due to the COVID-19 pandemic

DANB made the following temporary policy changes after DANB moved to telecommuting for its entire staff beginning March 18, 2020 and DANB's testing provider, Pearson VUE, closed inperson test centers from March 16 through mid-May 2020 due to the COVID-19 pandemic.

CPR Waiver for DANB Certification Exam Candidates

Candidates unable to obtain a DANB-recognized, hands-on CPR, BLS or ACLS certificate must download and complete a waiver form at danb.org and acknowledge that CPR, BLS or ACLS certificate will be required for renewal for any certification resulting from the exam they take now.

Changes to ID Requirements for DANB Exam Candidates

Candidates unable to renew a government-issued ID may use an expired ID at test centers and with online proctored exams.

<u>Changes to Intent-to-Graduate Documentation Requirements for some DANB Exam Candidates</u> Candidates from dental assisting programs accredited by CODA who are not graduating on time due to program changes related to COVID-19 must obtain a letter from the program director on school letterhead with the new expected date of program graduation, which will be entered into DANB's CRM system so that candidate's application can be tracked for follow-up to ensure that DANB's graduation requirements for some exams is ultimately met.

Temporary Suspension of Cancellation Fee

To accommodate changes in financial situation and/or DANB's capacity to test candidates, DANB is suspending the cancellation fee of \$40 for candidates who applied for and scheduled DANB exams and decided not to take them. The \$75 nonrefundable exam application processing fee stands.

<u>Changes to II.220.0 National Entry Level Dental Assistant Certification Eligibility Requirement</u> The Board approved changes to NELDA eligibility requirements. Additions are in **bold**; deletions are in strikethrough.

Eligibility requirements to earn NELDA certification common to pathways I, II, III, IV:

- Pass all three component exams within a 3-year period
 - Anatomy, Morphology and Physiology (AMP)
 - Infection Control (ICE)
 - Radiation Health and Safety (RHS)
- Hold current DANB-accepted, hands-on Cardiopulmonary Resuscitation (CPR), Basic Life Support (BLS) or Advanced Cardiac Life Support (ACLS) certification, must be current at time of application and exam.
- May not exceed 3,000 hours of dental assisting experience accrued over a period of at least two months and no more than three years, as verified by a licensed dentist.
- You-Must apply for NELDA certification within 3 years of passing the first component exam.
- If NELDA certificant later pursues CDA certification, they must take General Chairside (GC) exam within seven years of passing first NELDA component exam, assuming they have continuously maintained their NELDA certification for 4 years.

Extension of Grace Period for DANB Certification Renewal

DANB temporarily extended certificants' renewal grace periods for an additional three months, for a total of six months. Certificants will receive emails notifying them when they have entered into the extended grace period. Until further notice, DANB is waiving late fees for certificants who renew no later than three months past their expiration date. Certificants who need more flexibility may renew up to six months after their expiration date, although a \$20 late fee will apply beginning with the fourth month beyond an individual's DANB certification expiration date.

Update on DANB Collaborations

OSAP-DANB-DALE Foundation Collaboration

DANB and the DALE Foundation are collaborating with the Organization for Safety, Asepsis and Prevention (OSAP) on a comprehensive infection control education and credentialing initiative, called the OSAP-DANB-DALE Foundation *Dental Infection Prevention and Control Education and Credentialing Collaboration*TM.

The initiative establishes two education and two certification initiatives:

Dental Infection Prevention and Control Education

- A three-step OSAP-DALE Foundation *Dental Infection Prevention and Control Certificate Program[™]* (As of 3/10/2020, all three components of this OSAP-DALE Foundation Certificate Program are available)
- A number of short OSAP-DALE Foundation online dental infection control Continuing Dental Education Articles[™] (CDEA[®]) modules of 1 to 3 Continuing Dental Education (CDE) credits

Dental Infection Prevention and Control Certification Programs

- 1) OSAP-DANB Dental Industry Specialist in Infection Prevention and Control[™] (DISIPC[™]) certification
- 2) OSAP-DANB Certified in Dental Infection Prevention and Control[™] (CDIPC[™]) certification

Outcomes from the OSAP-DANB-DALE Foundation collaboration will advance the organizations' missions, all of which relate to enhancing patient and practitioner safety.

Collaboration with Temple University

DANB and the DALE Foundation are once again collaborating with Temple University's Kornberg School of Dentistry on its post-baccalaureate program for aspiring dental students. The program, which began in June 2015, includes an innovative combination of dental assisting training and practice, as well as advanced translational science courses.

The program provides students who are interested in studying dentistry an opportunity to

advance their education and improve their admission application for dental school.

In addition to traditional classroom lecture and clinical hours, the program includes unique elements offered by DANB and the DALE Foundation. All students have access to the DALE Foundation's review courses and practice tests that are designed to help them prepare for DANB's Radiation Health and Safety (RHS); Infection Control (ICE); and Anatomy, Morphology and Physiology (AMP) exams — which make up the exam components of DANB's National Entry Level Dental Assistant (NELDA) certification program, and to earn NELDA certification, if eligible.

Students must pass these three DANB exams to be permitted to assist dental students enrolled in Temple University's Kornberg School of Dentistry, in the clinic clusters. As in previous years, dental students looked forward to specifically asking for the post-baccalaureate students to assist them during their clinical coursework and also to assist them during clinical licensure board exams.

Following successful completion of the NELDA exams, post-baccalaureate students completed the OSAP-DALE Foundation Dental Infection Prevention and Control Certificate Program[™].

This sixth year of Temple University Kornberg School of Dentistry's Post-Baccalaureate Program began at the end of May 2020 and continues through April 2021. After successfully completing the program, students who meet the published admission criteria and have applied through the formal admission process may be conditionally accepted to Temple University's Doctor of Dental Medicine program.
