



# New Jersey Dental Radiologic Technologist Requirements

This information is valid as of Jan. 1, 2025.

The New Jersey Radiologic Technology Board of Examiners (Board) licenses dental radiologic technologists in New Jersey. The Board recognizes the Dental Assisting National Board, Inc. (DANB) Radiation Health and Safety (RHS®) exam as its licensing exam in dental radiologic technology.

To legally operate dental x-ray equipment and perform dental radiographic procedures in New Jersey, a dental assistant must be licensed as a Dental Radiologic Technologist (DRT) by the New Jersey Radiologic Technology Board of Examiners

To obtain this license, one must complete all of the following requirements:

**Be at least 18 years of age**



**Be a high school graduate or its equivalent**



**Be of good moral character**



## Pathway I

1. Successfully complete a New Jersey state-approved dental radiography course (see p. 2) or its equivalent
2. Pass the DANB Radiation, Health and Safety (RHS) exam

Both requirements must be completed **within** five years prior to application



## Pathway II

1. Successfully complete a New Jersey state-approved dental radiography course (see p. 2) or its equivalent more than five years prior to application
2. Pass the DANB Radiation Health and Safety (RHS) exam within five years prior to application
3. Document competent work experience\* in performing dental radiographic procedures within five years prior to application

\*It is illegal to obtain this work experience in New Jersey without the permission of the New Jersey Bureau of X-Ray Compliance.



## Pathway III

1. Successfully complete a New Jersey state-approved dental radiography course (see p. 2) or its equivalent
2. Hold current DANB Certified Dental Assistant™ (CDA®) certification



**Apply** for license from the State of New Jersey Bureau of X-Ray Compliance after completing all of the above requirements.
